2022 Summer Swimming Program

- We offer Group (4 students per class), Semi-Private (2 students per class), and Private swim lessons.
- All classes are 30 minutes per lesson.
- Based on your child's swimming level, our teachers concentrate on teaching your child how to tread water, breath under water, learn different strokes, and much more.
- Each child progresses at his/her own rate, and our teachers will assess their abilities to determine if he/she needs to be moved up or down to the best-suited level. You will be notified of the teacher's recommendations.
- Due to COVID-19, your child is required to be dressed appropriately before they enter the pool: swimming suit, goggles, and a hair-tie for longer hair. Pool bathrooms will be used only for emergencies.
- **You must find your own partner for semi-private swim. If one student drops, the other student is responsible for the private lesson price unless you can find another student to take their place.**

A \$50 registration fee is required to process a file. This fee is waived for current Arborland students.

Tuition is due upon enrollment. No student will be accepted for any lessons until the full payment is received. No invoices will be given. Parents are responsible to pay before lessons.

No make-ups or reduction in tuition will be provided for missed Group/Semi-private lessons.

Cancellation notices for private swimming lessons must be provided at least 24 hours prior to the scheduled lesson time to receive tuition credit.

There will be a \$100 service charge if your child causes the pool to close.

There will be a \$30 surcharge for all returned checks or bounced batch credit cards. If a check is returned, only cash, cashier's check, or money orders will be accepted for the remainder of the summer.

Refund/withdraw policy

All tuition and registration fees are non-refundable.
